BY-LAW No. 161-2004

To amend By-law No. 31001 of the former City of North York, as amended, regarding Betty Ann Drive, Everson Drive, Harrison Garden Boulevard, Humberstone Drive, Rippleton Road, Sentinel Road, The Pond Road and York Ridge Road.

The Council of the City of Toronto HEREBY ENACTS as follows:
