**CITY OF TORONTO**

**BY-LAW No. 179-2004**

**To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding Don Mills Road, Lawrence Avenue East, William R. Allen Road and York Mills Road.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule I (Pedestrians Prohibited on Certain Highways) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the words and figures:
