**CITY OF TORONTO**

**BY-LAW No. 185-2004**

**To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding Bloor Street West, F. G. Gardiner Expressway and Lake Shore Boulevard West.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of Metropolitan By-law No. 32-92, as amended, is further amended by striking out the words and figures:

Bloor Street (M.T. 10)	South	A point 45.5 metres west of High Park Avenue and Kennedy Avenue	4:00 p.m. to 6:00 p.m. except Saturdays, Sundays and Public Holidays
Lake Shore Boulevard West (M.T. 2)	South	A point 110.0 metres west of Lake Crescent and a point 35.0 metres east thereof	Anytime

where they occur opposite each other in Columns 1, 2, 3 and 4 of the said Schedule and inserting in lieu thereof the following:

Bloor Street West (M.T. 10)	South	Clendenan Avenue and a point 45.5 metres west of High Park Avenue	4:00 p.m. to 6:00 p.m. Monday to Friday except Public Holidays
Bloor Street West (M.T. 10)	South	Ellis Park Road and Clendenan Avenue	Anytime
Bloor Street West (M.T. 10)	South	Kennedy Avenue and Ellis Park Road	4:00 p.m. to 6:00 p.m. Monday to Friday except Public Holidays
Lake Shore Boulevard West (M.T. 2)	South	A point 80 metres west of Lake Crescent and a point 12 metres east	Anytime

2. Schedule IX (No Stopping) of Metropolitan By-law No. 32-92, as amended, is further amended by inserting the following words and figures opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Lake Shore Boulevard West (M.T. 2)	South	A point 110.0 metres west of Lake Crescent and a point 30 metres east	Anytime

3. Schedule XIII (One-Way Traffic Lanes) of Metropolitan By-law No. 32-92, as amended, is further amended by inserting the following words and figures opposite each other in Columns 1, 2, 3, 4 and 5 of the said Schedule:

F. G. Gardiner Expressway westbound off-ramp to Kipling Avenue	Kipling Avenue and a point 50 metres east	Centre Westbound	Anytime	Westbound right-turning Westbound left-turning
F. G. Gardiner Expressway westbound off-ramp to Kipling Avenue	Kipling Avenue and a point 50 metres east	Northerly Westbound	Anytime	Westbound right-turning
F. G. Gardiner Expressway westbound off-ramp to Kipling Avenue	Kipling Avenue and a point 50 metres east	Southerly Westbound	Anytime	Westbound left-turning
