CITY OF TORONTO

BY-LAW No. 220-2004

To amend City of Toronto Municipal Code Chapter 849, Water and Sewage Services, respecting water rates and sewer service rates.

WHEREAS it is necessary and appropriate for the City of Toronto to set water rates and a sewer service rate;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Section 849-15 of Chapter 849, Water and Sewage Services, Rates, Consumers in former Borough of East York, is repealed and replaced with the following:

"§ 849-15. Consumers in former Borough of East York.

Water shall be supplied from the City of Toronto to consumers in the former Borough of East York on the terms and conditions set out in By-law No. 11-90 of the former Borough of East York, as amended, except that Schedule A to By-law No. 11-90 of the former Borough of East York shall be and is hereby amended by striking out the paragraph entitled "WATER RATES" [4(j)] and replacing it with Schedule A at the end of this by-law."

2. Section 849-16 of Chapter 849, Water and Sewage Services, Rates, Consumers in former City of Etobicoke, is repealed and replaced with the following:

"§ 849-16. Consumers in former City of Etobicoke.

- A. Water shall be supplied from the City of Toronto to metered consumers in the former City of Etobicoke on the terms and conditions set out in § 257-16 A, B, C and D(1), Article I (Water Rates) of the Municipal Code of the former City of Etobicoke in effect in the former City of Etobicoke for the year 1997 except as amended, at the combined water and sewer service rates set out in the attached Schedule A at the end of this chapter.
- B. Water shall be supplied from the City of Toronto to unmetered consumers in the former City of Etobicoke on the terms and conditions set out in § 257-16 A, B, C and D(1), Article I (Water Rates) of the Municipal Code of the former City of Etobicoke in effect in the former City of Etobicoke for the year 1997 except as amended, at the combined water and sewer service rates set out in the attached Schedule F at the end of this chapter."

3. Section 849-17 of Chapter 849, Water and Sewage Services, Rates, Consumers in former City of North York, is repealed and replaced with the following:

"§ 849-17. Consumers in former City of North York.

Water shall be supplied from the City of Toronto to consumers in the former City of North York on the terms and conditions set out in By-law No. 32925 of the former City of North York, except that the rates for the water shall be as set out in the attached Schedule A at the end of this Chapter."

4. Section 849-18 of Chapter 849, Water and Sewage Services, Rates, Consumers in former City of Scarborough, is repealed and replaced with the following:

"§ 849-18. Consumers in former City of Scarborough.

Water shall be supplied from the City of Toronto to consumers in the former City of Scarborough on the terms and conditions set out in the resolutions of the former Public Utilities Commission of the City of Scarborough at the rates set out in the attached Schedule A at the end of this Chapter."

5. Section 849-19 of Chapter 849, Water and Sewage Services, Rates, Consumers in former City of Toronto, is repealed and replaced with the following:

"§ 849-19. Consumers in former City of Toronto.

- A. Water shall be supplied by the City of Toronto to metered consumers in the former City of Toronto on the terms and conditions set out in Chapter 340 of the Municipal Code of the former City of Toronto at the rates set out in the attached Schedule A at the end of this Chapter.
- B. Water shall be supplied by the City of Toronto to flat rate consumers in the former City of Toronto on the terms and conditions set out in Chapter 340 of the Municipal Code of the former City of Toronto and those consumers shall pay the combined water and sewer service rates as set out in the attached Schedules B, C and D at the end of this Chapter."
- **6.** Section 849-20 of Chapter 849, Water and Sewage Services, Rates, Consumers in former City of York, is repealed and replaced with the following:

"§ 849-20. Consumers in former City of York.

Water shall be supplied by the City of Toronto to consumers in the former City of York in accordance with By-law No. 1259-71 of the former City of York, as amended, at the combined water and sewer service rates set out in the attached Schedule A at the end of this Chapter."

- 7. Schedule A to Chapter 849, Art. II Combined Water and Sewer Service Rates for Consumers in the former City of Etobicoke is repealed and replaced with Schedule A, attached to this by-law.
- 8. Schedule B to Chapter 849, Art. II, List of Annual Combined Water and Sewer Service Rates for Flat Rate Consumers in Dwelling Houses and Rooming Houses in the former City of Toronto is repealed and replaced with Schedule B attached to this by-law.
- **9.** Schedule C to Chapter 849, Art. II, List of Annual Combined Water and Sewer Service Rates for Flat Rate Consumers in the former City of Toronto is repealed and replaced with Schedule C, attached to this by-law.
- **10.** Schedule D to Chapter 849, Art. II, List of Annual Combined Water and Sewer Service Rates for Flat Rate Consumers in the former City of Toronto is repealed and replaced with Schedule D, attached to this by-law.
- **11.** Schedule F to this by-law is added as Schedule F to Chapter 849 of the Municipal Code.
- **12.** This by-law comes into effect on the 1st day of April, 2004.
