BY-LAW No. 227-2004

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Church Street, Farnham Avenue, Lambertlodge Avenue, Lonsdale Road, Markham Street, Public Laneway north of Balliol Street, Robert Street and Shallmar Boulevard.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
 - A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:
