BY-LAW No. 309-2004

**To amend By-law No. 31001 of the former City of North York, as amended, regarding
Addington Avenue, Gerry Fitzgerald Drive, Jainey Place, Lytton Boulevard and
Tangiers Road.**

The Council of the City of Toronto HEREBY ENACTS as follows:
