CITY OF TORONTO

BY-LAW No. 333-2004

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Burnfield Avenue, Cherry Street, George Street, Gould Street, Havelock Street, Jones Avenue, Mill Street, Shuter Street, South Drive, Trinity Street and Williamson Road.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
