CITY OF TORONTO

BY-LAW No. 394-2004

To amend the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Wexford Heights Business Improvement Area and to establish a Board of Management for the Wexford Heights Business Improvement Area.

WHEREAS Council, by the adoption of By-law No. 199-2004 designated an area along Lawrence Avenue East from Victoria Park Avenue to just east of Birchmount Road, as a business improvement area under section 204 of the *Municipal Act*, 2001; and

WHEREAS by the adoption of Clause No. 10 of Economic Development and Parks Committee Report No. 3 on May 18, 19 and 20, 2004, City of Toronto Council established a board of management for the Wexford Heights Business Improvement Area, and appointed members to the Wexford Heights Business Improvement Area Board of Management for a term expiring on November 30, 2006, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Wexford Heights Business Improvement Area Board of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

- **1.** The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - A. The table in Schedule A, Boards of Management is amended by adding the new Wexford Heights Board of Management as set out in Schedule A attached;
 - B. Schedule A, Maps is amended by adding the attached maps of the Wexford Heights Business Improvement Area; and
 - C. The table in § 19-2 is amended by inserting in the first column "199-2004" and by inserting in the third column "Wexford Heights".
- **2.** A Board of Management for the Wexford Heights Business Improvement Area is hereby established.




SCHEDULE A WEXFORD HEIGHTS BUSINESS IMPROVEMENT AREA MAP LOT 5
