CITY OF TORONTO

BY-LAW No. 395-2004

**To amend the City of Toronto Municipal Code Chapter 19, Business Improvement Areas,
to include the new Emery Village Business Improvement Area and to establish a Board of
Management for the Emery Village Business Improvement Area.**

WHEREAS Council, by the adoption of By-law No. 265-2003 designated an area from Steeles Avenue West to the north and Sheppard Avenue West to the south, west of Highway 400 with an irregular western boundary from Sheppard Avenue West to Steeles Avenue West, as a business improvement area under section 220 of the former *Municipal Act*, which by-law came into force on March 8, 2004 by order of the Ontario Municipal Board; and

WHEREAS by the adoption of Clause No. 10 of Economic Development and Parks Committee Report No. 3 on May 18, 19 and 20, 2004, City of Toronto Council established a board of management for the Emery Village Business Improvement Area, and appointed members to the Emery Village Business Improvement Area Board of Management for a term expiring on November 30, 2006, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Emery Village Business Improvement Area Board of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - A. The table in Schedule A, Boards of Management is amended by adding the new Emery Village Board of Management as set out in Schedule A attached;
 - B. Schedule A, Maps is amended by adding the attached maps of the Emery Village Business Improvement Area; and
 - C. The table in § 19-2 is amended by inserting in the first column "265-2003" and by inserting in the third column "Emery Village".
2. A Board of Management for the Emery Village Business Improvement Area is hereby established.

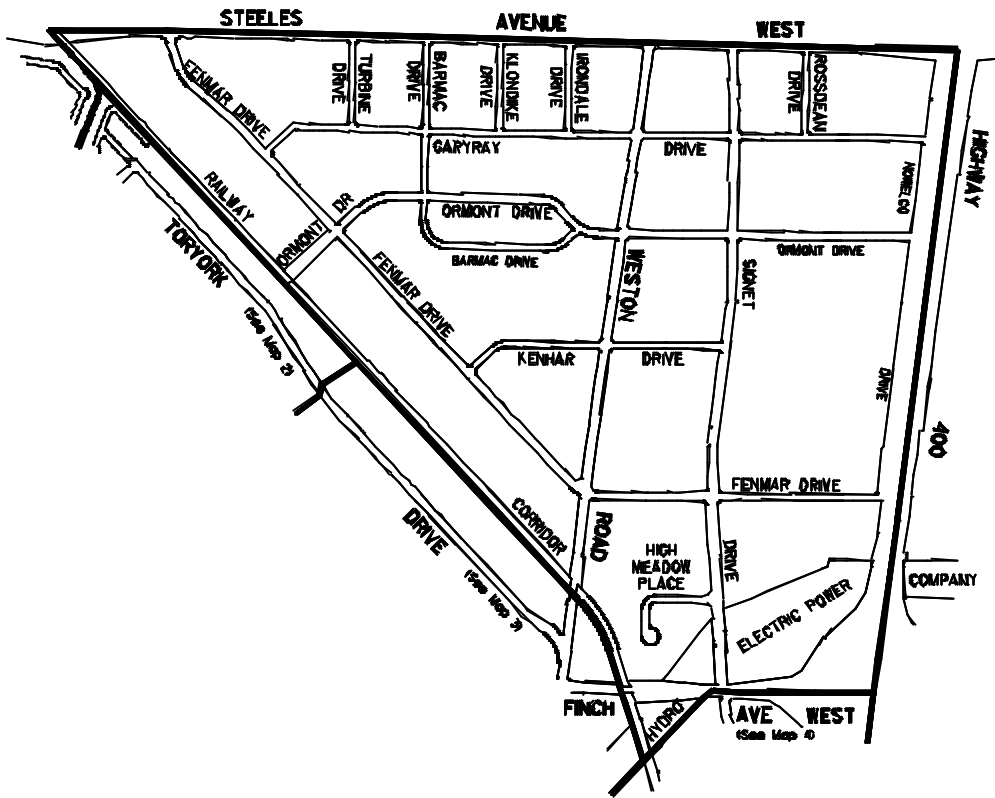

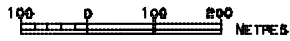
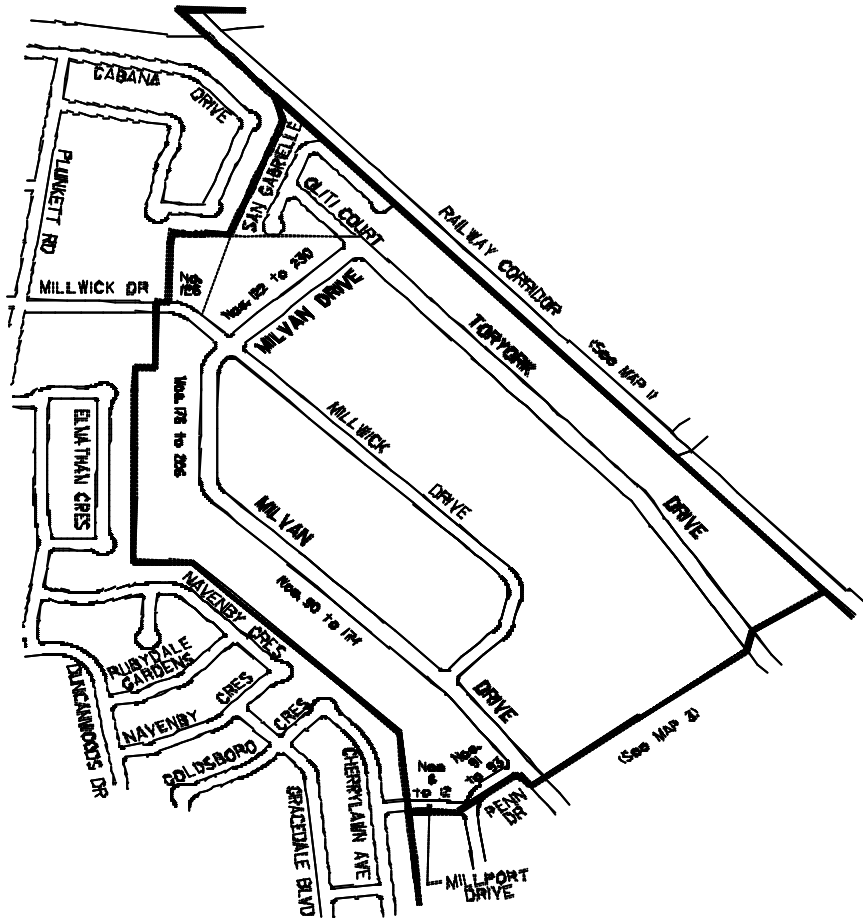
SCHEDULE A

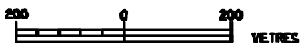
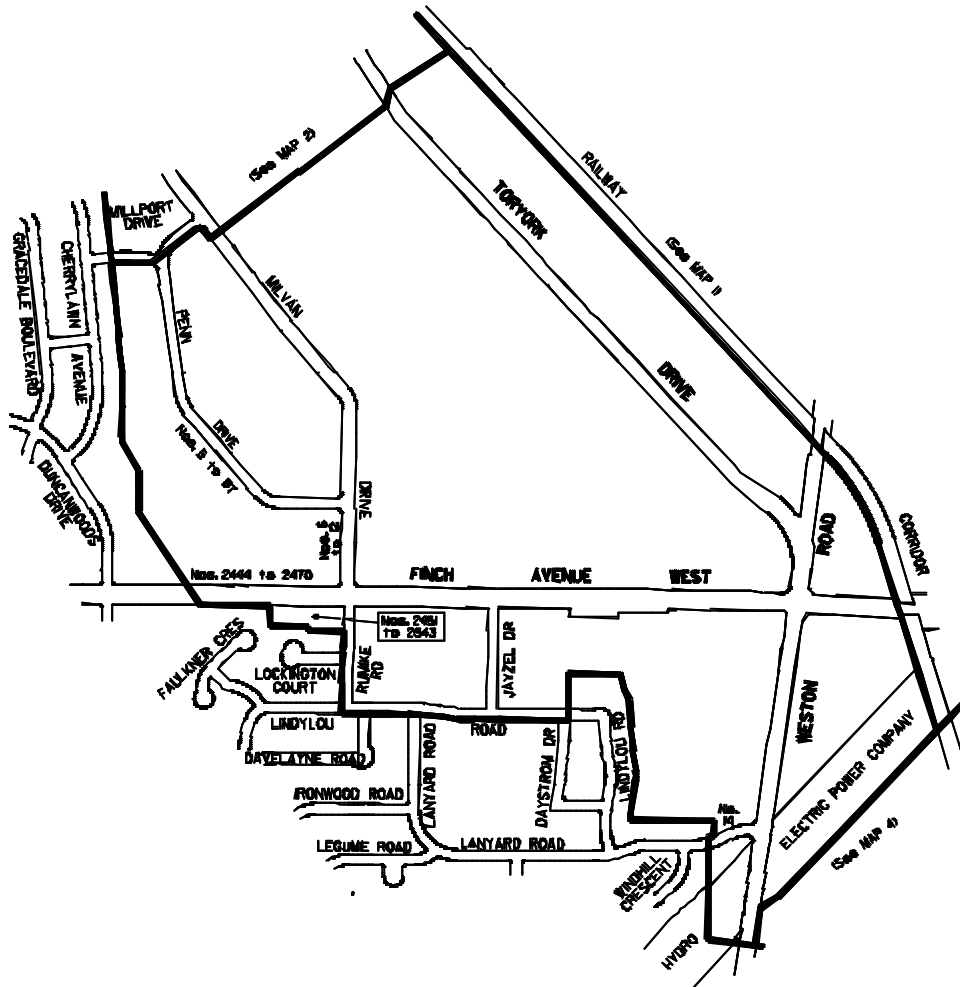
SCHEDULE A
