## BY-LAW No. 416-2004

## To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Parkmount Road.

WHEREAS in order to provide for permit parking between 12:00 midnight to 10:00 a.m., seven days a week, and from 4:00 p.m. to 7:00 p.m., Monday to Friday, it is necessary to create a new Part of Schedule XXVI (Permit Parking) of the former City of Toronto Municipal Code Chapter 400, Traffic and Parking;

The Council of the City of Toronto HEREBY ENACTS as follows:

- **1.** Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
- A. By deleting from §§ 400-38B and 400-38D(1): "AI, AJ, AK or AL" and replacing it with: "AI, AJ, AK, AL or AM".
- B. By inserting in § 400-38E the following:
  - "Part AM 12:00 midnight to 10:00 a.m., daily, and 4:00 p.m. to 7:00 p.m., Monday to Friday".
- C. By deleting from § 400-38G(2)(a): "AI, AJ, AK or AL" and replacing it with: "AI, AJ, AK, AL or AM".
- D. By deleting from Part A of Schedule XXVI (Permit Parking) in § 400-79 the following in alphabetical order by street name:
