BY-LAW No. 418-2004

To amend further Metropolitan By-law No. 107-86, respecting parking meters on former Metropolitan Roads, regarding Adelaide Street East.

The Council of the City of Toronto HEREBY ENACTS as follows:

- Schedule I of former Metropolitan By-law No. 107-86, being a By-law "Respecting parking meters on Metropolitan Roads", as amended, is further amended by striking out the following words and figures:
