CITY OF TORONTO

BY-LAW No. 644-2004

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
 respecting Crossovers Street, Gerrard Street East, Hannaford Street, Ted Reeve Drive,
 Whistle Post Street and William Hancox Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting in Schedule IV (Stop Intersections) in § 400-57, the following in alphabetical order by street name:
