CITY OF TORONTO

BY-LAW No. 645-2004

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Garden Avenue, Laneway system bounded by Dundas Street West, Annette Street, Indian Grove and Indian Road Crescent, Queen Street East and Widmer Street.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting in Schedule VIII (Prohibited Turns) in § 400-61, the following in alphabetical order by street name:
