CITY OF TORONTO

BY-LAW No. 694-2004

To amend City of Toronto Municipal Code Chapter 441, Fees, to establish fees or charges for waste management services provided to schools.

WHEREAS under section 391 of the *Municipal Act, 2001* a municipality may pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it; and

WHEREAS schools receive collection of waste from bulk or automated bins and deliver waste directly to the City's transfer stations;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Chapter 441, Fees, of The City of Toronto Municipal Code, is amended by adding the following:

§ 441-17. Waste management fees.

A. As used in this section, the following term has the meaning indicated:

SCHOOLS - Means the Toronto District School Board, the Toronto Catholic District School Board and the Conseil Scolaire de District Catholique Centre - Sud (French Catholic School board – South) and includes private schools, as defined in the *Education Act*, that utilize the services provided by the City.

B. The charges set out in Column 2 of the following table shall apply to schools receiving a waste collection and transfer station service as set out in Column 1:

| Automated "flower pots" | \$17.93 per "flower pot" |
| Transfer stations | \$70.00 per tonne |

- C. The charges established in Subsection B do not include taxes, and any applicable taxes shall be added to the charge.
- D. The charges established under this section shall be paid to the City by cash, money order, certified cheque, credit card or debit card on or before the payment due date as set out in the invoices for the type of collection service provided.
- E. The charge may be added to the tax roll for the property, all of the owners of which are responsible for paying the charge, to be collected in the same manner as municipal taxes.
- 2. This by-law comes into force on September 1, 2004.
