BY-LAW No. 766-2004

To amend By-law No. 2958-94 of the former City of York, being a By-law “To regulate traffic on City of York Roads”, regarding George Street.

The Council of the City of Toronto HEREBY ENACTS as follows:

NO PARKING - SCHEDULE VIII

1. That Schedule VIII of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
George Street	West	King Street and a point 99.1 metres north thereof	8:00 a.m. to 6:00 p.m., Monday to Friday
George Street	West	A point 82.2 metres south of Fern Avenue and Church Street	8:00 a.m. to 6:00 p.m., Monday to Friday
George Street	East	A point 57 metres north of King Street and a point 97.7 north thereof	8:00 a.m. to 6:00 p.m., Monday to Friday
George Street	East	A point 154.7 metres north of King Street and Church Street	Anytime

NO PARKING - SCHEDULE VIII

2. That Schedule VIII of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
George Street	West	King Street and a point 31 metres north thereof	Anytime

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> Prohibited <u>Times or Days</u>
George Street	West	A point 146.3 metres north of King Street and Church Street	8:00 a.m. to 6:00 p.m., Monday to Friday
George Street	East	A point 123.7 metres north of King Street and Church Street	Anytime

3. That Schedule IX of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> Prohibited <u>Times or Days</u>
George Street	West	A point 130 metres south of Fern Avenue and a point 47.8 metres north thereof	Anytime
George Street	East	King Street and a point 57 metres north thereof	Anytime

4. That Schedule IX of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

George Street	West	A point 74.3 metres north of King Street and a point 72 metres north thereof	8:00 a.m. to 5:00 p.m., Monday to Friday
