## CITY OF TORONTO

### BY-LAW No. 774-2004

#### **To amend further Metropolitan By-law No. 32-92, respecting the regulation of traffic on former Metropolitan Roads, regarding eastbound off-ramp from Highway 400 at Jane Street and Lake Shore Boulevard West.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Schedule VIII (No Parking) of Metropolitan By-law No. 32-92, as amended, is further amended by inserting the following words and figures opposite each other in Columns 1, 2, 3 and 4 of the said Schedule:
