BY-LAW No. 776-2004

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Bellhaven Road, Brock Avenue, Chatham Avenue, Duart Park Road,
Gladstone Avenue, Jones Avenue, Manning Avenue, O'Hara Avenue, Palmerston Avenue,
Shaw Street, St. Clarens Avenue and Wembley Drive.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
 - A. By deleting from Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

Bellhaven Road	East	A point 2.5 metres north of the projected south curb line of Wrenson Road and a point 6 metres south	Anytime
Duart Park Road	South	A point 63.0 metres west of MacLean Avenue and a point 5.5 metres further west	Anytime
Gladstone Avenue	East	A point 39 metres north of Hallam Street and a point 5.5 metres further north	Anytime
Jones Avenue	West	A point 138 metres south of Mallon Avenue and a point 5.5 metres further south	Anytime

- B. By inserting in Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

Brock Avenue	West	A point 86.0 metres south of Wallace Avenue and a point 5.5 metres further south	Anytime

O'Hara Avenue	East	A point 15.0 metres north of Queen Street West and a point 5.5 metres further north	Anytime, from the 1st day of each month to the 15th day of each month, April 1st to Nov. 30th, inclusive
O'Hara Avenue	West	A point 28.0 metres north of Queen Street West and a point 5.5 metres further north	Anytime, from the 16th day of each month to the last day of each month, April 1st to Nov. 30th, inclusive, and from Dec. 1st of one year to March 31st of the next following year, inclusive
Palmerston Avenue	West	A point 186.5 metres north of Dundas Street West and a point 6.0 metres further north	Anytime
Shaw Street	East	A point 20.8 metres north of Essex Street and a point 6.0 metres further north	Anytime
St. Clarens Avenue	East	A point 82.0 metres north of College Street and a point 5.5 metres further north	Anytime
