BY-LAW No. 924-2004

To amend By-law No. 31001 of the former City of North York, as amended, regarding Ferrand Drive, Seton Park Road, Wilket Creek Road and Windom Road.

The Council of the City of Toronto HEREBY ENACTS as follows:
