BY-LAW No. 1059-2004

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Euclid Avenue and Temperance Street.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Euclid Avenue	Both	College Street and a point 42.7 metres north of it	Anytime
Temperance Street	Both	Sheppard Street and Bay Street	Anytime

B. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Euclid Avenue	West	College Street and a point 42.7 metres north	Anytime
Temperance Street	North	Sheppard Street and Bay Street	Anytime
Temperance Street	South	Sheppard Street and a point 60.0 metres west of Bay Street	Anytime
Temperance Street	South	Bay Street and a point 48.0 metres west	Anytime

C. By inserting in Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)
Euclid Avenue	East	College Street and a point 42.7 metres north	Anytime

D. By inserting in Schedule XXIX (No Standing) in § 400-82, the following in alphabetical order by street name:

Temperance Street	South	A point 48.0 metres west of Bay Street and a point 12.0 metres further west	Anytime

E. By inserting in Schedule XXXIX (Designated On-Street Loading Zones for Disabled Person Parking Permit Holders) in § 400-92, the following in alphabetical order by street name:

(In Column 1)	(In Column 2)	(In Column 3)	(In Column 4)	(In Column 5)
Temperance Street	South	A point 48.0 metres west of Bay Street	A point 12.0 metres further west	Anytime
