BY-LAW No. 1060-2004

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Hanna Avenue, Rosehill Avenue, Shaw Street and Wright Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
