BY-LAW No. 1063-2004

To amend By-law No. 3387-79 of the former City of York, a by-law with respect to fire routes in the geographic area of the former City of York.

WHEREAS, pursuant to the *City of Toronto Act, 1997, S.O. 1997, c. 2*, every by-law or resolution of an old council that is in force immediately before January 1st, 1998 is deemed to be a by-law or resolution of the Council of the City of Toronto and remains in force, in respect of the part of the urban area to which it applied immediately before January 1st, 1998, until the Council repeals it or amends it to provide otherwise; and

WHEREAS By-law No. 3387-79 of the former City of York provides for the designation of a private roadway in the geographic area of the former York as a fire route; and

WHEREAS By-law No. 3387-79 was in force in the former City of York immediately before January 1st, 1998 and has not been repealed or amended to provide otherwise by the Council of the City of Toronto; and

WHEREAS the owner of buildings situated 2525 St. Clair Avenue West in the former City of York has applied for the designation of two fire routes on its property, as provided for in By-law No. 3387-79; and

WHEREAS the Fire Department of the City has reviewed the owner's application and has no objections to the proposed fire route designations and, as a result, supports this application;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. That By-law No. 3387-79 of the former City of York, being a by-law with respect to fire routes, be amended by inserting therein Schedules B-(44) and C-(44) attached to this by-law.
