CITY OF TORONTO

BY-LAW No. 1078-2004

To amend the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Beaches Business Improvement Area and to establish a Board of Management for the Beaches Business Improvement Area.

WHEREAS Council, by the adoption of By-law No. 582-2004 designated an area between Lockwood Road and Neville Park Road, as a business improvement area under section 204 of the *Municipal Act*, 2001; and

WHEREAS by the adoption of Clause No. 8 of Economic Development and Parks Committee Report No. 8 on November 30, December 1 and 2, 2004, City of Toronto Council established a board of management for the Beaches Business Improvement Area, and appointed members to the Beaches Business Improvement Area Board of Management for a term expiring on November 30, 2006, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Beaches Business Improvement Area Board of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

- **1.** The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - A. The table in Schedule A, Boards of Management is amended by adding the new Beaches Board of Management as set out in Schedule A attached;
 - B. Schedule A, Maps is amended by adding the attached maps of the Beaches Business Improvement Area; and
 - C. The table in § 19-2 is amended by inserting in the first column "582-2004" and by inserting in the third column "Beaches".
- 2. A Board of Management for the Beaches Business Improvement Area is hereby established.
