CITY OF TORONTO

BY-LAW No. 57-2006

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Gore Vale Avenue, Havelock Street, Lambertlodge Avenue, Lappin Avenue, Lippincott Street, Macdonell Avenue, Maughan Crescent, Paton Road, Sarnia Avenue, and Waverley Road.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

Macdonell Avenue	West	A point 32.5 metres south of Galley Avenue and a point 5.5 metres further south	Anytime
Maughan Crescent	East	A point 17 metres north of Dundas Street East and a point 5.5 metres further north thereof	Anytime
Sarnia Avenue	North	A point 48.5 metres east of Campbell Avenue and a point 5.5 metres further east	Anytime
Waverley Road	East	A point 139 metres south of Norway Avenue and a point 5.5 metres further south thereof	Anytime

B. By inserting in Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

Gore Vale Avenue	East	A point 32 metres south of Dundas Street West and a point 6 metres further south	Anytime

Lambertlodge Avenue	South	A point 58 metres east of the west leg of Melita Crescent and a point 5.5 metres further east	Anytime
Lappin Avenue	South	A point 162 metres west of Dufferin Street and a point 5.5 metres further west	Anytime
Lippincott Street	East	A point 9 metres north of Oxford Street and a point 5.5 metres further north	Anytime
Paton Road	North	A point 6.2 metres east of Campbell Avenue and a point 5.5 metres further east	Anytime
