BY-LAW No. 58-2006

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Niagara Street and Simcoe Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

- A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

| (From Column 1) | (From Column 2) | (From Column 3) | (From Column 4) |
|--------------------|--------------------|--|--------------------|
| Simcoe Street | West | King Street West and Station Street | Anytime |

- B. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

| Niagara Street | East | Adelaide Street West and a point 36 metres south of Queen Street West | Anytime |
| Niagara Street | East | A point 36 metres south of Adelaide Street West and a point 34 metres further south | 9:30 a.m. to 3:00 p.m. and from 6:00 p.m. of one day to 8:00 a.m. of the next following day, Mon. to Fri.; Anytime Sat. and Sun. |
| Niagara Street | East and North | Portland Street and a point 70 metres south of Adelaide Street West | Anytime |
| Simcoe Street | West | Station Street and Wellington Street West | Anytime |

C. By deleting from Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

E. By inserting in Schedule XXV (Time Limit Parking) in § 400-78, the following in alphabetical order by street name:

|----------------|---------------|---|--|---------------|
| Niagara Street | East | A point 36 metres south of Adelaide Street West and a point 34 metres further south | 8:00 a.m. to 9:30 a.m., and 3:00 p.m. to 6:00 p.m., Mon. to Fri. | 10 mins. |

F. By inserting in Schedule XXIX (No Standing) in § 400-82, the following in alphabetical order by street name:
