BY-LAW No. 66-2006

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Strachan Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

E. By deleting from Schedule XXIX (No Standing) in § 400-82, the following in alphabetical order by street name:

Strachan Avenue	West	Lake Shore Boulevard West and a point 119 metres north of Fleet Street	Anytime
