CITY OF TORONTO

BY-LAW No. 158-2006

To amend the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Uptown Yonge Business Improvement Area and to establish a Board of Management for the Uptown Yonge Business Improvement Area.

WHEREAS Council, by the adoption of By-law No. 765-2005 designated an area along Yonge Street between Roehampton Avenue and Glengrove Avenue as a business improvement area under section 204 of the *Municipal Act, 2001*; and

WHEREAS by the adoption of Clause 3, of Economic Development and Parks Committee Report 1, on January 31, February 1 and 2, 2006, City of Toronto Council established a board of management for the Uptown Yonge Business Improvement Area, and appointed members to the Uptown Yonge Business Improvement Area Board of Management for a term expiring on November 30, 2006, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Uptown Yonge Business Improvement Area Board of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - A. the table in Schedule A, Boards of Management is amended by adding the new Uptown Yonge Board of Management as set out in Schedule A attached;
 - B. Schedule A, Maps is amended by adding the attached maps of the Uptown Yonge Business Improvement Area; and
 - C. the table in § 19-2 is amended by inserting in the first column “765-2005” and by inserting in the third column “Uptown Yonge”.
2. A Board of Management for the Uptown Yonge Business Improvement Area is hereby established.

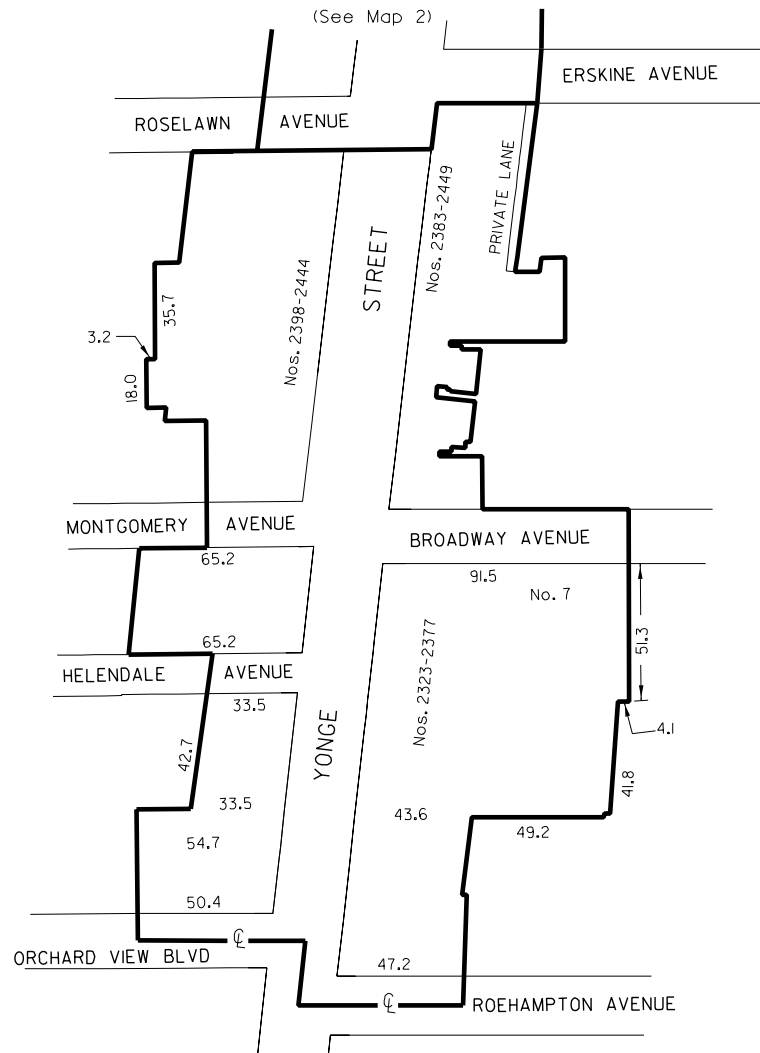

MAP 1 of 4

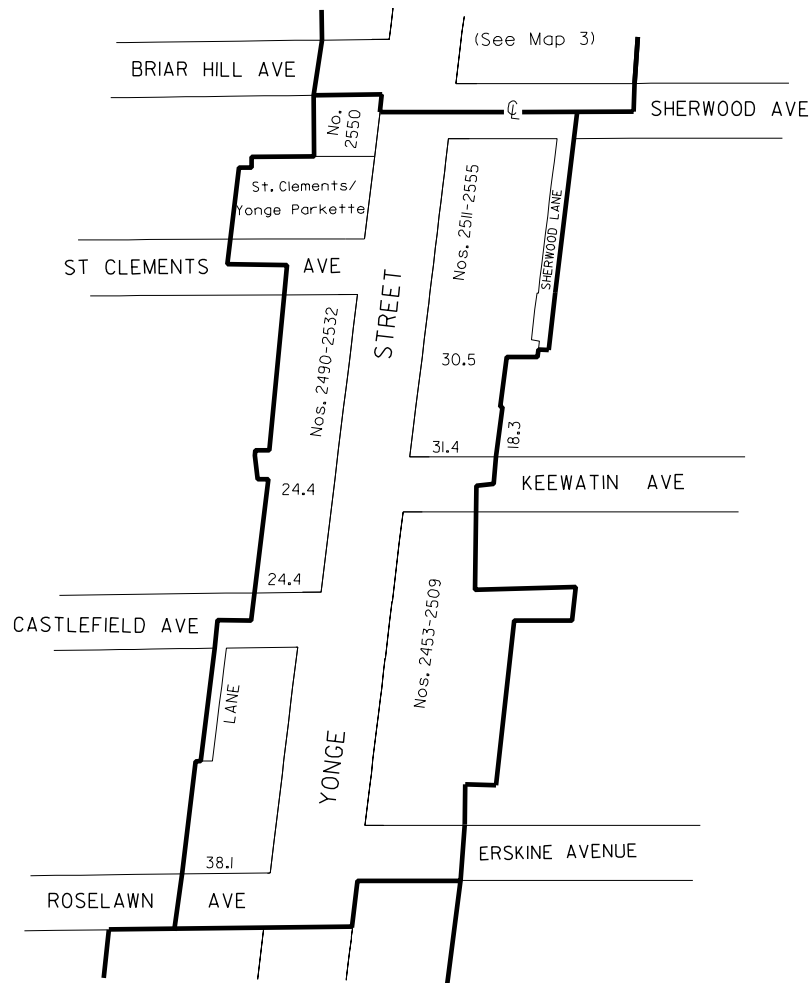

MAP 2 of 4



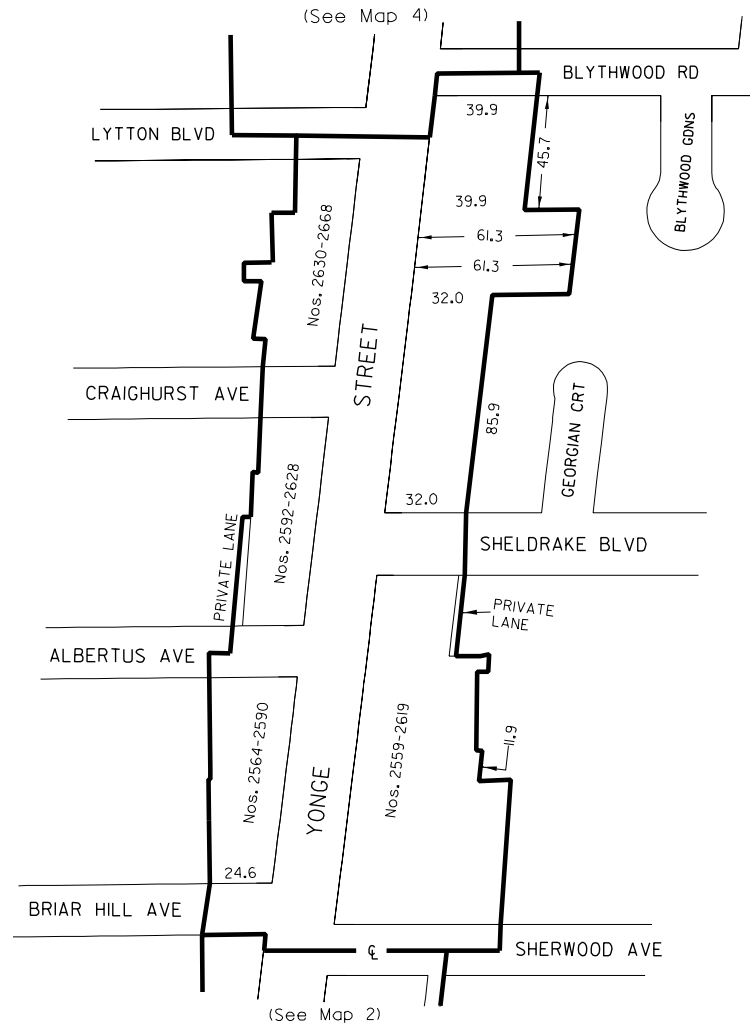

MAP 3 of 4

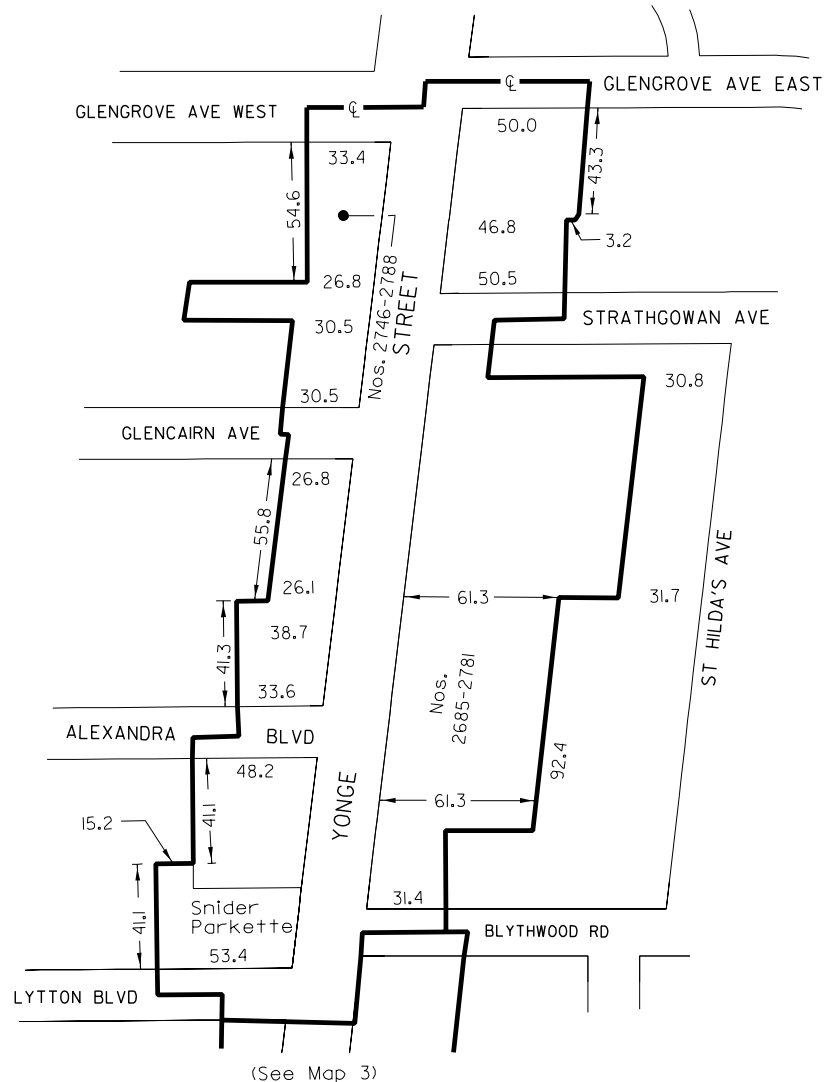
