BY-LAW No. 240-2006

**To amend By-law No. 196-84 of the former City of York, being a By-law
“To regulate traffic on City of York Roads”, regarding Carrington Avenue,
Ennerdale Road and Winfield Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

NO PARKING - SCHEDULE VIII

1. That Schedule VIII of former City of York By-law No. 196-84, as amended, be further amended by deleting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Carrington Avenue	South	Harvie Avenue and Nairn Avenue	Anytime
Winfield Avenue	North	The westerly terminus street and Willard Avenue	Anytime

NO PARKING - SCHEDULE VIII

2. That Schedule VIII of former City of York By-law No. 196-84, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Carrington Avenue	South	A point 77 metres east of Harvie Avenue and Nairn Avenue	Anytime
Ennerdale Road	East	A point 53.5 metres north of Holmesdale Road and a point 5.5 metres further north	Anytime

<u>Column 1 Highway</u>	<u>Column 2 Side</u>	<u>Column 3 Between</u>	<u>Column 4 Prohibited Times or Days</u>
Winfield Avenue	North	The westerly terminus street and Willard Avenue	from the first day of each month to the 15th day of each month, April 1st to November 30th, inclusive
Winfield Avenue	South	The westerly terminus street and Willard Avenue	from the 16th day of each month to the last day of each month, April 1st to November 30th, inclusive
Winfield Avenue	North	The westerly terminus street and Willard Avenue	Anytime, from the 1st day of December to the 31st day of March, inclusive

NO STOPPING - SCHEDULE IX

3. That Schedule IX of former City of York By-law No. 196-84, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1 Highway</u>	<u>Column 2 Side</u>	<u>Column 3 Between</u>	<u>Column 4 Prohibited Times or Days</u>
Carrington Avenue	South	Harvie Avenue and a point 77 metres further east	Anytime

PARKING FOR RESTRICTED PERIODS - SCHEDULE X

4. That Schedule X of former City of York By-law No. 196-84, as amended, be further amended by inserting in Columns 1, 2, 3, 4 and 5 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>	<u>Column 5</u> <u>Maximum</u> <u>Period</u> <u>Permitted</u>
Carrington Avenue	South	A point 53 metres east of Harvie Avenue and a point 24 metres further east	8:30 a.m. to 10:00 a.m., and 11:30 a.m. to 1:30 p.m., and 3:30 p.m. to 5:00 p.m., Monday to Friday	10 Min.
