BY-LAW No. 259-2006

To amend City of Toronto Municipal Code Chapter 441, Fees.

WHEREAS Schedule C to § 441-16 of Chapter 441, Fees, provides a Scale of Costs for Tax Sale Proceedings Under Part XI of the Municipal Act, Sale of Land for Tax Arrears; and

WHEREAS it is recommended that Schedule C to § 441-16 be amended to include the cost of a Preliminary Observation Report in the amount of \$250.00;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 441, Fees, is amended by deleting Schedule C to § 441-16 and replacing it with the following:
