CITY OF TORONTO

BY-LAW No. 271-2006

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting, Bartlett Avenue, Fern Avenue, Glebemount Avenue, Hazelwood Avenue, Kimberley Avenue, Perth Avenue, Rolyat Street, Strickland Avenue and Wolfrey Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

Glebemount Avenue	West	A point 21 metres north of Milverton Boulevard and a point 7 metres further north	Anytime
Kimberley Avenue	Both	A point 74.5 metres north of Lyall Avenue and a point 5.5 metres further north thereof	Anytime
Perth Avenue	East	A point 34 metres south of Wallace Avenue and a point 5.5 metres further south thereof	Anytime
Rolyat Street	North	A point 49 metres east of Grove Avenue and a point 5.5 metres further east	Anytime

B. By inserting in Schedule XXXVIII (Designated On-Street Parking for Disabled Person Parking Permit Holders) in § 400-91, the following in alphabetical order by street name:

Bartlett Avenue	West	A point 5 metres north of Southview Avenue and a point 5.5 metres further north	Anytime
Fern Avenue	South	A point 68.5 metres west of Roncesvalles Avenue and a point 5.5 metres further west	Anytime
Hazelwood Avenue	South	A point 118 metres west of Jones Avenue and a point 5.5 metres further west	Anytime
