BY-LAW No. 280-2006

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Bartlett Avenue, Gladstone Avenue and Hallam Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Bartlett Avenue	A point 84 metres north of Bloor Street West and Dupont Street	Anytime	From south to north
Gladstone Avenue	Dupont Street and Shanly Street	Anytime	From north to south

B. By inserting in Schedule I (One-Way Highways) in § 400-54, the following in alphabetical order by street name:

Bartlett Avenue	A point 84 metres north of Bloor Street West and Shanly Street	Anytime	Northbound
Bartlett Avenue	Hallam Street and Dupont Street	Anytime	Northbound

Gladstone Avenue	Hallam Street and Dupont Street	Anytime	Southbound
Gladstone Avenue	Shanly Street and Hallam Street	Anytime	Northbound

C. By deleting from Schedule IV (Stop Intersection) in § 400-57, the following in alphabetical order by street name:
