CITY OF TORONTO

BY-LAW No. 326-2006

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Ascot Avenue, Innes Avenue, Innisfree Court and Worthington Crescent.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
