CITY OF TORONTO

BY-LAW No. 404-2006

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Arlington Avenue, Benson Avenue, Burnside Drive, Hendrick Avenue,
Hillcrest Drive, Tyrrel Avenue and Wychwood Avenue.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:
 - A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:
