**CITY OF TORONTO**

**BY-LAW No. 573-2006**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,  
respecting Albert Street, Front Street West and James Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

|--------------------|--------------------|-------------------------------|--------------------|
| Front Street West  | North              | Simcoe Street and John Street | Anytime            |

B. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

|-------------------|------------------|--|------------------|
| Front Street West | North            | John Street and a point 54.5 metres<br>west of Simcoe Street | Anytime          |
| Front Street West | North            | Simcoe Street and a point 30.5 metres<br>west                | Anytime          |

C. By deleting from Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

| Albert Street      | South              | Bay Street and James Street | Anytime            |

D. By inserting in Schedule XXIV (No Stopping) in § 400-77, the following in alphabetical order by street name:

E. By inserting in Schedule XXXIX (Designated On-Street Loading Zones for Disabled Person Parking Permit Holders) in § 400-92, the following in alphabetical order by street name:

| (In<br>Column 1)  | (In<br>Column 2) | (In<br>Column 3)                             | (In<br>Column 4)                  | (In<br>Column 5) |
|-------------------|------------------|--|-----------------------------------|------------------|
| Albert Street     | South            | A point 16.3 metres<br>east of Bay Street    | A point 12 metres<br>further east | Anytime          |
| James Street      | West             | Albert Street                                | A point 15 metres<br>south        | Anytime          |
| Front Street West | North            | A point 30.5 metres<br>west of Simcoe Street | A point 24 metres<br>further west | Anytime          |
