The Council of the City of Toronto HEREBY ENACTS as follows:

**1.** Schedule XIX (Compulsory Stops) of By-law No. 92-93, as amended, being a by-law of the former Borough of East York, is hereby further amended by inserting the following words and figures opposite each other in Columns 1 and 2 of the said Schedule:

Adair Road and Squires Avenue	On Adair Road (westbound) east of Squires Avenue
Furnival Road and Valor Boulevard	On Furnival Road (eastbound) west of Valor Boulevard

Peard Road and Squires Avenue	On Peard Road (westbound) east of Squires Avenue
Valor Boulevard and Furnival Road	On Valor Boulevard (northbound) south of Furnival Road
Valor Boulevard and Furnival Road	On Valor Boulevard (southbound) north of Furnival Road
Valor Boulevard and Merritt Road	On Valor Boulevard (southbound) north of Merritt Road
Valor Boulevard and Topham Road	On Valor Boulevard (northbound) south of Topham Road
Westview Boulevard and Galbraith Avenue	On Westview Boulevard (northbound) south of Galbraith Avenue
Westview Boulevard and Galbraith Avenue	On Westview Boulevard (southbound) north of Galbraith Avenue
