**CITY OF TORONTO**

**BY-LAW No. 597-2006**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,  
respecting Cariboo Avenue, Fern Avenue, Galley Avenue and Shuter Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XVI (Speed Limits on Highways) in § 400-69, the following in alphabetical order by street name:
