CITY OF TORONTO

BY-LAW No. 625-2006

To amend City of Toronto Municipal Code Ch. 910, former City of Toronto Municipal Code Ch. 400, former North York By-law No. 30742, former Etobicoke Municipal Code Ch. 187, former Scarborough By-law No. 22614, former York By-law No. 1645-89, former Metropolitan Toronto By-law No. 107-86, former East York By-law No. 197, former York Municipal Code Ch. 982 and City of Toronto Municipal Code Ch. 950, to provide an exemption to Ontario Veterans from payment at on-street parking meters and parking machines and in municipal parking facilities where attendants are stationed on the anniversary of Battle of Britain (September 17) and on Remembrance Day (November 11) commencing in 2006 and the anniversary of D-Day (June 6) commencing in 2007.

The Council of the City of Toronto HEREBY ENACTS as follows:

- 1. Chapter 910, Parking Machines, is amended as follows:
 - A. By deleting § 910-2A and replacing it with the following:
 - "910-2A. Despite any other provision in this chapter, where a fee is stipulated in this chapter for a given parking period in a parking space, the requirement to pay or deposit a fee and to use or activate the parking machine shall not apply on September 17 and November 11 of each year, commencing in 2006 and on June 6 of each year, commencing in 2007, to persons operating a vehicle to which a valid Ontario Veteran licence plate is registered and affixed."
- **2.** Chapter 400, Traffic and Parking, of the former City of Toronto Municipal Code, is amended as follows:
 - A. By deleting Section A.1 in § 400-42 and replacing it with the following:
 - "A.1. Despite any other provision in § 400-42, where a fee is stipulated in § 400-42 for a given parking period in a parking space, the requirement to pay or deposit a fee or rate and to use or set in operation the parking meter or to use or activate the parking machine shall not apply on September 17 and November 11 of each year, commencing in 2006 and on June 6 of each year, commencing in 2007 to persons operating a vehicle to which a valid Ontario Veteran licence plate is registered and affixed."

- **3.** By-law No. 30742, being "A By-law Respecting Parking Meters on the City of North York Roads", of the former City of North York, is amended as follows:
 - A. By deleting Section 3.1 and replacing it with the following:
 - "3.1. Despite any other provision of this By-law, where a rate or fee is stipulated in this By-law for a given parking period in a parking space, the requirement to pay or deposit the rate or fee shall not apply on September 17 and November 11 of each year, commencing in 2006 and on June 6 of each year, commencing in 2007 to persons operating a vehicle to which a valid Ontario Veteran licence plate is registered and affixed."
- **4.** Chapter 187, Parking Meters, of the Municipal Code of the former City of Etobicoke, is amended as follows:
 - A. By deleting 187-3.2 and replacing it with the following:
 - "187-3.2. Despite any other provision of this chapter, where a fee is stipulated in this chapter for a given parking period in a parking space, the requirement to pay or deposit the fee or rate and to use or set in operation the parking meter shall not apply on September 17 and November 11 of each year, commencing in 2006 and on June 6 of each year, commencing in 2007 to persons operating a vehicle to which a valid Ontario Veteran licence plate is registered and affixed."
- 5. By-law No. 22614, being "A By-law Respecting Parking Meters on Scarborough Roads", of the former City of Scarborough, is amended as follows:
 - A. By deleting Section 2.1 and replacing it with the following:
 - "2.1. Despite any other provision of this By-law, where a rate or fee is stipulated in this By-law for a given parking period in a parking space, the requirement to pay or deposit the rate or fee and to use the parking meter shall not apply on September 17 and November 11 of each year, commencing in 2006 and on June 6 of each year, commencing in 2007 to persons operating a vehicle to which a valid Ontario Veteran licence plate is registered and affixed."
- **6.** By-law No. 1645-89, being "A By-law Respecting Parking Meters", of the former City of York, is amended as follows:
 - A. By deleting Section 2.1 and replacing it with the following:
 - "2.1. Despite any other provision of this By-law, where a rate or fee is stipulated in this By-law for a given parking period in a parking space, the requirement to pay or deposit the rate or fee and to use or set in operation the parking meter shall not apply on September 17 and November 11 of

each year, commencing in 2006 and on June 6 of each year, commencing in 2007 to persons operating a vehicle to which a valid Ontario Veteran licence plate is registered and affixed."

- 7. By-law No. 107-86, being "A By-law Respecting Parking Meters on Metropolitan Roads", of the former Municipality of Metropolitan Toronto, is amended as follows:
 - A. By deleting Section 2.1 and replacing it with the following:
 - "2.1. Despite any other provision of this By-law, where a rate or fee is stipulated in this By-law for a given parking period in a parking space, the requirement to pay or deposit the rate or fee and to use or set in operation the parking meter shall not apply on September 17 and November 11 of each year, commencing in 2006 and on June 6 of each year, commencing in 2007 to persons operating a vehicle to which a valid Ontario Veteran licence plate is registered and affixed."
- **8.** By-law No. 197, being a by-law "To provide for parking meters on roads in the Borough of East York", of the former Borough of East York, is amended as follows:
 - A. By deleting Section 2.1 and replacing it with the following:
 - "2.1. Despite any other provision of this By-law, where a rate or fee is stipulated in this By-law for a given parking period in a parking space, the requirement to pay or deposit the rate or fee and to use or set in operation the parking meter shall not apply on September 17 and November 11 of each year, commencing in 2006 and on June 6 of each year, commencing in 2007 to persons operating a vehicle to which a valid Ontario Veteran licence plate is registered and affixed."
- **9.** Chapter 982, Parking Meter, of the former City of York Municipal Code, is amended as follows:
 - A. By deleting Section 982.2.1A and replacing it with the following:
 - "982.2.1A. Despite any other provision of this chapter, where a fee is stipulated in this chapter for a given parking period in a parking space, the requirement to pay or deposit the fee and to use or set in operation the parking meter shall not apply on September 17 and November 11 of each year, commencing in 2006 and on June 6 of each year, commencing in 2007 to persons operating a vehicle to which a valid Ontario Veteran licence plate is registered and affixed."

- **10.** Chapter 950, Traffic and Parking, of The City of Toronto Municipal Code, is amended as follows:
 - A. By deleting Section Q in § 950-601 and replacing it with the following:
 - "Q. Despite any other provision in this article, the requirement to pay or deposit a fee and to use, set in operation, or activate a parking machine or parking meter shall not apply on September 17 and November 11 of each year, commencing in 2006 and on June 6 of each year, commencing in 2007 to persons operating a vehicle to which a valid Ontario Veteran licence plate is registered and affixed."
- **11.** Chapter 950, Traffic and Parking, of The City of Toronto Municipal Code, is amended as follows:
 - A. By deleting Section R in § 950-601 and replacing it with the following:
 - "R. Despite any other provision in this article, the requirement to pay or deposit a fee or rate with a parking attendant at an attendant-operated car-park shall not apply on September 17 and November 11 of each year, commencing in 2006 and on June 6 of each year, commencing in 2007 to persons operating a vehicle to which a valid Ontario Veteran licence plate is registered and affixed."
