**CITY OF TORONTO**

**BY-LAW No. 627-2006**

**To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas,  
to include the new Danforth Village Business Improvement Area and to establish a  
Board of Management for the Danforth Village Business Improvement Area.**

WHEREAS Council, by the adoption of By-law No. 388-2006, designated an area along Danforth Avenue between Victoria Park Avenue and just west of Westlake Avenue, as a business improvement area under section 204 of the *Municipal Act, 2001*; and

WHEREAS by the adoption of Economic Development and Parks Committee Report 5, Clause 4, at its meeting of July 25, 26 and 27, 2006, City of Toronto Council established a board of management for the Business Improvement Area, and appointed members to the Danforth Village Business Improvement Area Board of Management for a term expiring on November 30, 2006, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Danforth Village Business Improvement Area Board of Management;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
  - A. The table in Schedule A, Boards of Management is amended by adding the new Danforth Village Board of Management as set out in Schedule A attached;
  - B. Schedule A, Maps is amended by adding the attached maps of the Danforth Village Business Improvement Area; and
  - C. The table in § 19-2 is amended by inserting in the first column "388-2006" and by inserting in the third column "Danforth Village".
2. A Board of Management for the Danforth Village Business Improvement Area is hereby established.

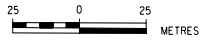
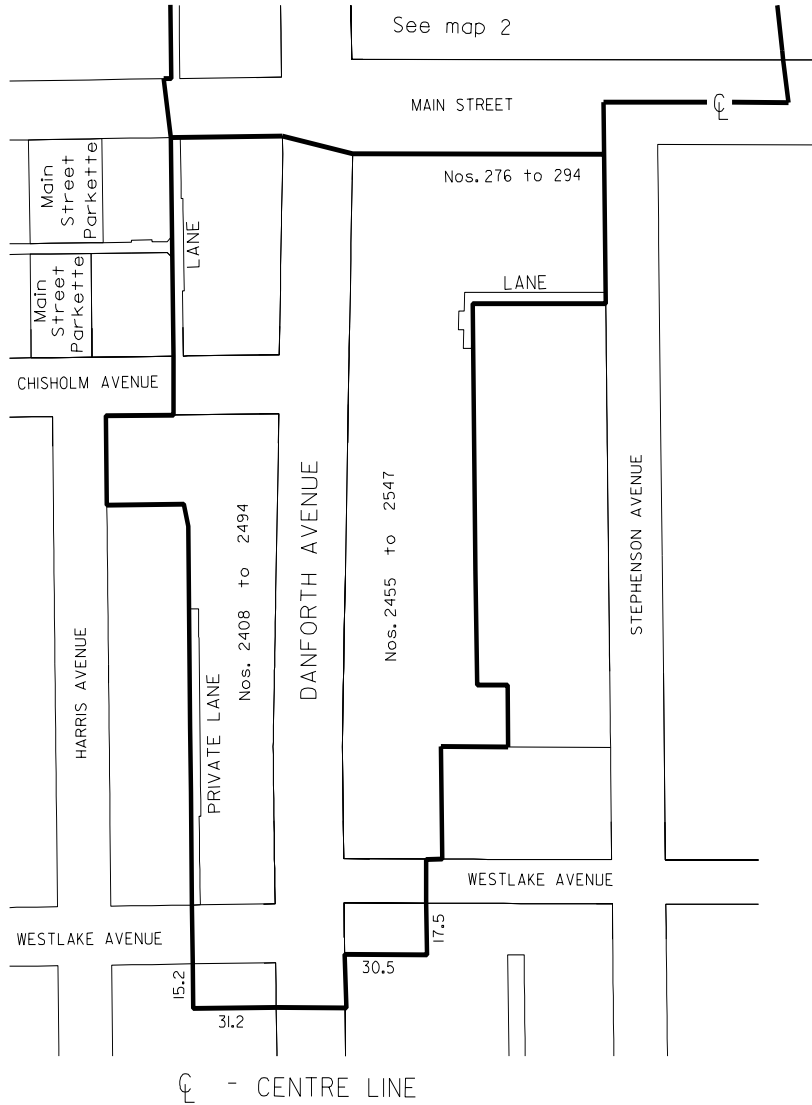

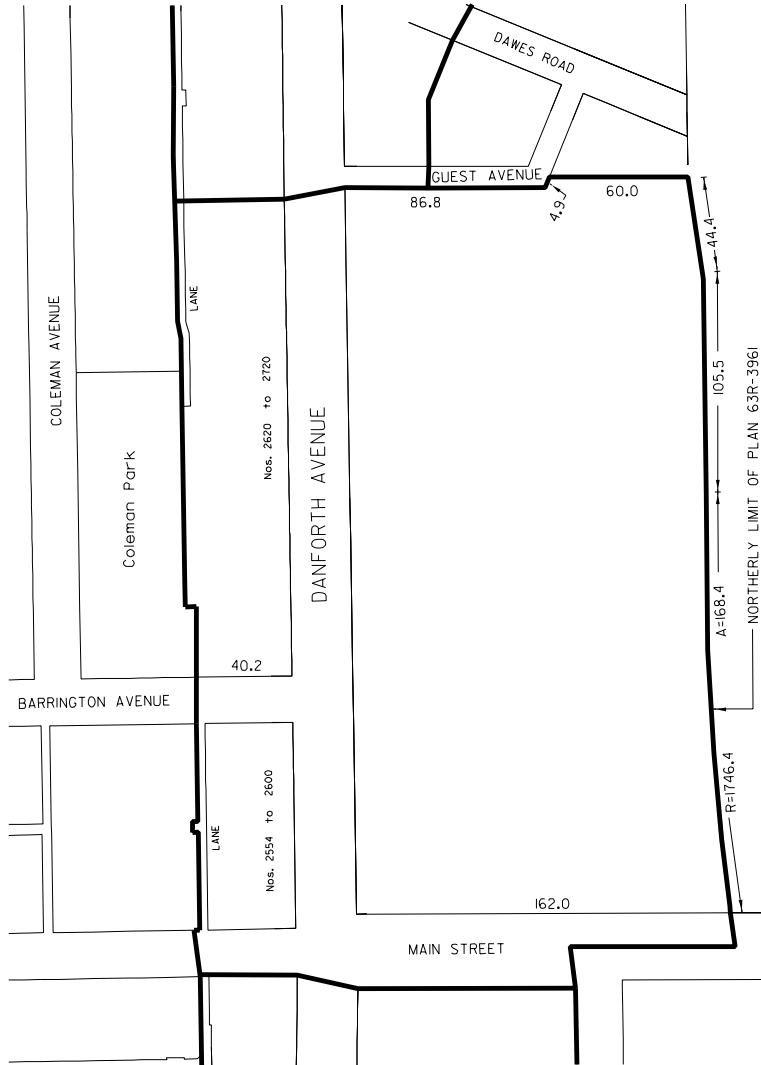
SCHEDULE A

(Map 1 of 4)



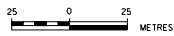

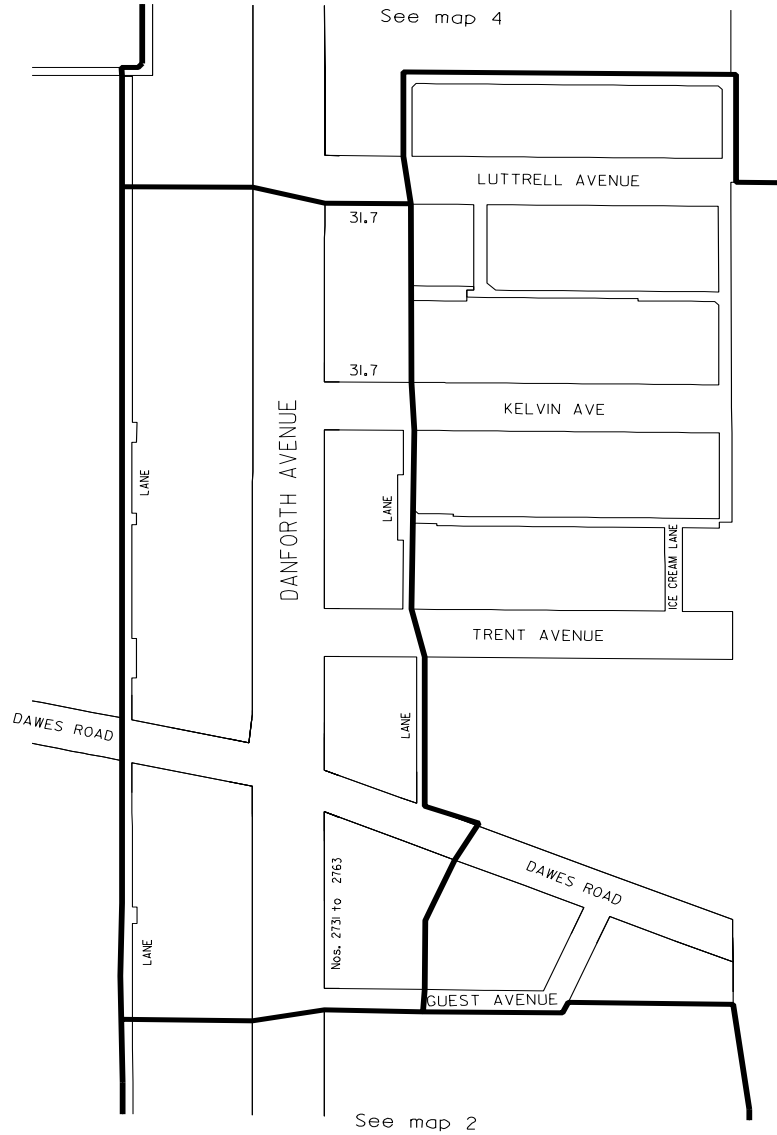

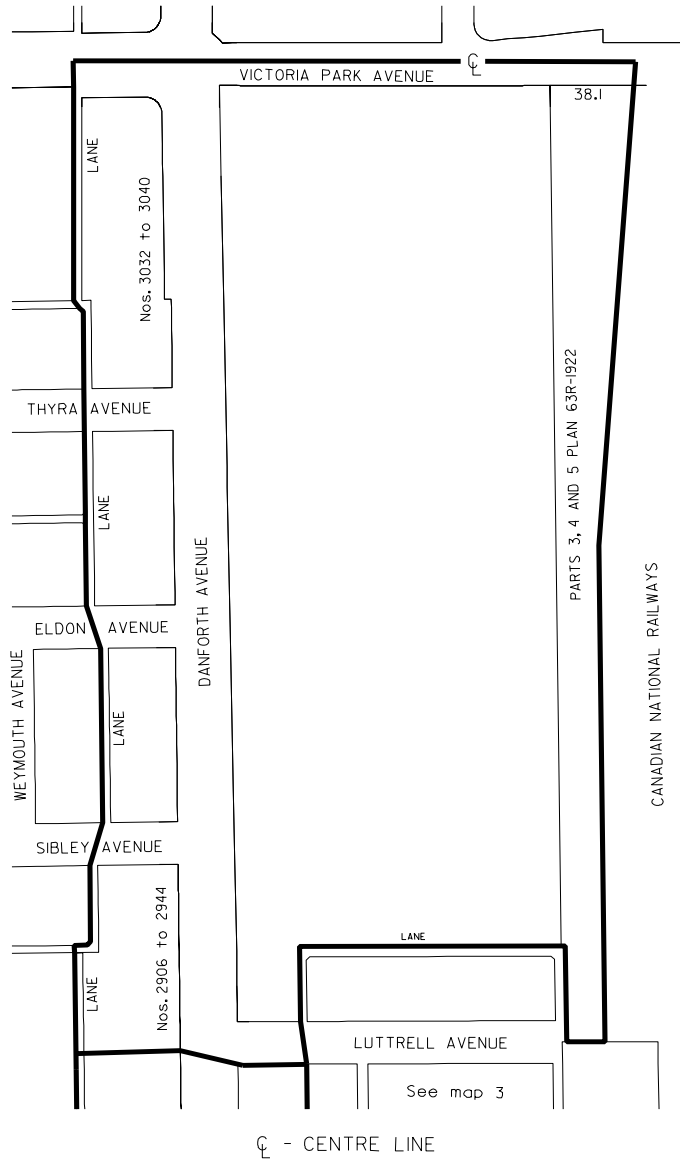
SCHEDULE A
