CITY OF TORONTO

BY-LAW No. 638-2006

To levy an amount for the year 2006 upon certain Public Hospitals and Provincial Mental Health Facilities.

WHEREAS subsection 323(3) of the *Municipal Act, 2001*, as amended (the “Act”), provides among other things that, notwithstanding any general or special Act, the Council of a local municipality may pass by-laws to levy an annual amount upon a public hospital or provincial mental health facility designated by the Minister of Health and Long-Term Care not exceeding the prescribed amount for each provincially rated bed in the public hospital or provincial mental health facility as determined by the Minister of Health and Long-Term Care; and

WHEREAS pursuant to Ontario Regulation 384/98, as amended, the sum of \$75 is prescribed for 2006, for the purposes of subsection 323(3) of the Act; and

WHEREAS the Minister of Health and Long-Term Care has designated the following institutions as public hospitals or provincial mental health facilities for the purposes of subsection 323(3) of the Act and has determined the following to be provincially rated beds:
