BY-LAW No. 721-2006

To amend By-law No. 2958-94 of the former City of York, being a By-law “To regulate traffic on City of York Roads”, regarding Avenal Drive and Warwick Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

NO PARKING – SCHEDULE VIII

1. That Schedule VIII of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1, 2, 3 and 4 of said Schedule the following:

Avenal Drive	North	Bathurst Street and Strathearn Road	Anytime

Warwick Avenue	North	Chiltren Hill Road and a point 110.5 metres east of Chiltren Hill Road	9:15 a.m. to 3:00 p.m., and 6:00 p.m. to 7:15 a.m. of the next following day, Monday to Friday and all day Saturday and Sunday

2. That Schedule VIII of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:
