CITY OF TORONTO

BY-LAW No. 804-2006

To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to reflect the expanded boundaries of the St. Lawrence Market Neighbourhood Business Improvement Area.

WHEREAS Chapter 19, Business Improvement Areas of The City of Toronto Municipal Code designates various areas of the City as Business Improvement Areas, including the St. Lawrence Market Neighbourhood Business Improvement Area; and

WHEREAS by the enactment of By-law No. 803-2006 on September 25, 26 and 27, 2006, City of Toronto Council designated an area that includes the existing St. Lawrence Market Neighbourhood Business Improvement Area (as described in former City of Toronto By-law No. 1994-0572) as an improvement area; and

WHEREAS Schedule A of Toronto Municipal Code Chapter 19, Business Improvement Areas must be amended to reflect the designation of the expanded St. Lawrence Market Neighbourhood Business Improvement Area;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
 - A. The table in Schedule A of Toronto Municipal Code, Chapter 19, Business Improvement Areas, is amended by deleting By-law No. "1994-0572 (Toronto)" beside the name "St. Lawrence Market Neighbourhood" in the "Designating By-law (Former Municipality)" column and substituting "803-2006";
 - B. Schedule A, Maps is amended by deleting the map of the St. Lawrence Market Neighbourhood Business Improvement Area and substituting the map of the St. Lawrence Market Neighbourhood Business Improvement Area attached to this by-law; and
 - C. The table in § 19-2 is amended by inserting in the second column "803-2006" and by inserting in the third column "St. Lawrence Market Neighbourhood".

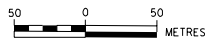
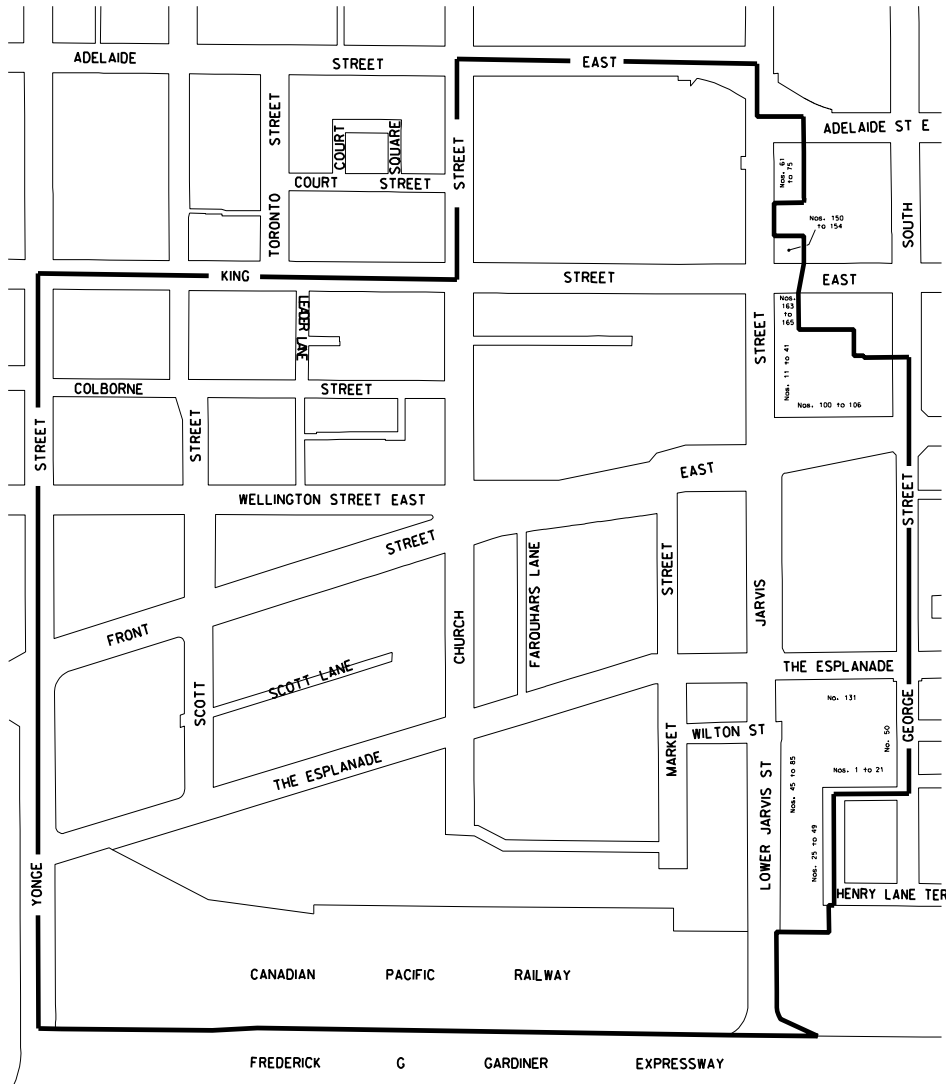
