BY-LAW No. 892-2006

**To amend By-law No. 31001 of the former City of North York, as amended, regarding
Dallimore Circle, David Dunlap Circle, Humphrey Gate and Jessie Drive.**

The Council of the City of Toronto HEREBY ENACTS as follows:
