**CITY OF TORONTO**

**BY-LAW No. 941-2006**

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,  
respecting Bay Street, Isabella Street, Macpherson Avenue and Sudbury Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By inserting in Schedule I (One-Way Highways) in § 400-61, the following in alphabetical order by street name:

Bay Street and the driveway access from No. 1 Dundas Street West, located on the east side of Bay Street at a point 71 metres north of Hagerman Street	Westbound	Left	7:30 a.m. to 9:30 a.m. and 3:30 p.m. to 6:30 p.m., Mon. to Fri.

B. By inserting in Schedule XVI (Speed Limits on Highways) in § 400-69, the following in alphabetical order by street name:

C. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:
