BY-LAW No. 946-2006

**To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking,
respecting Frankish Avenue, Hilltop Road and Queens Quay West.**

The Council of the City of Toronto HEREBY ENACTS as follows:
