**CITY OF TORONTO**

**BY-LAW No. 1018-2006**

**To amend By-law No. 2958-94 of the former City of York, being a By-law “To regulate traffic on City of York Roads”, regarding Hollis Street.**

The Council of the City of Toronto HEREBY ENACTS as follows:

NO PARKING – SCHEDULE VIII

1. That Schedule VIII of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Hollis Street	South	Weston Road and the easterly terminus street	Anytime

NO PARKING – SCHEDULE VIII

2. That Schedule VIII of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Hollis Street	South	A point 64 metres east of Weston Road and the easterly terminus street	Anytime

NO STOPPING – SCHEDULE IX

3. That Schedule IX of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>
Hollis Street	North	A point 26 metres east of Weston Road and a point 15.5 metres further east	Anytime

PARKING FOR RESTRICTED PERIODS – SCHEDULE X

4. That Schedule X of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1, 2, 3, 4 and 5 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>	<u>Column 5</u> <u>Maximum</u> <u>Period</u> <u>Permitted</u>
Hollis Street	North	Weston Road and the easterly terminus street	8:00 a.m. to 7:00 p.m.	60 Min.

PARKING FOR RESTRICTED PERIODS – SCHEDULE X

5. That Schedule X of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3, 4 and 5 of said Schedule the following:

<u>Column 1</u> <u>Highway</u>	<u>Column 2</u> <u>Side</u>	<u>Column 3</u> <u>Between</u>	<u>Column 4</u> <u>Prohibited</u> <u>Times or Days</u>	<u>Column 5</u> <u>Maximum</u> <u>Period</u> <u>Permitted</u>
Hollis Street	North	Weston Road and a point 26 metres east thereof	8:00 a.m. to 7:00 p.m.	60 Min.
Hollis Street	North	A point 41.5 metres east of Weston Road and the easterly terminus street	8:00 a.m. to 7:00 p.m.	60 Min.
