BY-LAW No. 1020-2006

To amend By-law No. 2958-94 of the former City of York, being a By-law “To regulate traffic on City of York Roads”, regarding Roselawn Avenue.

The Council of the City of Toronto HEREBY ENACTS as follows:

NO PARKING – SCHEDULE VIII

1. That Schedule VIII of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1 Highway</u>	<u>Column 2 Side</u>	<u>Column 3 Between</u>	<u>Column 4 Prohibited Times or Days</u>
Roselawn Avenue	South	Castlefield Avenue and Locksley Avenue	Anytime
Roselawn Avenue	North	Castlefield Avenue and Marlee Avenue	Anytime
Roselawn Avenue	South	A point 90 metres west of Marlee Avenue and Marlee Avenue	Anytime

NO STOPPING – SCHEDULE IX

2. That Schedule IX of former City of York By-law No. 2958-94, as amended, be further amended by deleting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1 Highway</u>	<u>Column 2 Side</u>	<u>Column 3 Between</u>	<u>Column 4 Prohibited Times or Days</u>
Roselawn Avenue	South	Times Road and Danesbury Avenue	8:00 a.m. to 6:00 p.m.
Roselawn Avenue	South	Danesbury Avenue and a point 90 metres west of Marlee Avenue	7:00 a.m. to 9:00 a.m., and 4:00 p.m. to 6:00 p.m., Monday to Friday

<u>Column 1 Highway</u>	<u>Column 2 Side</u>	<u>Column 3 Between</u>	<u>Column 4 Prohibited Times or Days</u>
Roselawn Avenue	North	Castlefield Avenue and Marlee Avenue	7:00 a.m. to 9:00 a.m., and 4:00 p.m. to 6:00 p.m., Monday to Friday
Roselawn Avenue	South	Locksley Avenue and Times Road	7:00 a.m. to 9:00 a.m., and 4:00 p.m. to 6:00 p.m., Monday to Friday

3. That Schedule IX of former City of York By-law No. 2958-94, as amended, be further amended by inserting in Columns 1, 2, 3 and 4 of said Schedule the following:

<u>Column 1 Highway</u>	<u>Column 2 Side</u>	<u>Column 3 Between</u>	<u>Column 4 Prohibited Times or Days</u>
Roselawn Avenue	North and South	Castlefield Avenue and Marlee Avenue	Anytime
