CITY OF TORONTO

BY-LAW No. 1052-2006

To amend the former City of Toronto Municipal Code Ch. 400, Traffic and Parking, respecting Alberta Avenue, Geary Avenue, Rosemount Avenue and Via Italia.

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Municipal Code Chapter 400, Traffic and Parking, of the former City of Toronto is amended as follows:

A. By deleting from Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Alberta Avenue	East	St. Clair Avenue West and the lane first north of Davenport Road	Anytime, from Dec. 1 of one year to Mar. 31 of the next following year, inclusive
Via Italia	West	A point 39 metres south of St. Clair Avenue West and Mackay Avenue	Anytime

B. By inserting in Schedule XXIII (No Parking Certain Times) in § 400-76, the following in alphabetical order by street name:
