BY-LAW No. 46-2008

To amend the City of Toronto Municipal Code Chapter 903, Parking for Persons with Disabilities, respecting Amroth Avenue, Armoury Street, Ashdale Avenue, Craven Road, Eastwood Road, Follis Avenue, Kerr Road, King Edward Avenue, Mutual Street and Stafford Street.

The Toronto and East York Community Council HEREBY ENACTS as follows:

1. Municipal Code Chapter 903, Parking for Persons with Disabilities, of the City of Toronto is amended as follows:
 - A. By deleting from Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

(From Column 1)	(From Column 2)	(From Column 3)	(From Column 4)
Amroth Avenue	West	A point 95 metres south of Danforth Avenue and a point 5.5 metres further south	Anytime
King Edward Avenue	East	A point 100 metres south of Lumsden Avenue and a point 5.5 metres further south	Anytime during the months of May, July, September and November
King Edward Avenue	West	A point 108 metres south of Lumsden Avenue and a point 5.5 metres further south	Anytime during the months of January, February, March, April, June, August, October and December

- B. By inserting in Schedule II (Designated On-Street Parking for Permit Holders), the following in alphabetical order by street name:

Craven Road	East	A point 149 metres north of Dundas Street East and a point 5.5 metres further north	Anytime

Eastwood Road	North	A point 57.5 metres east of Bowmore Road and a point 5.5 metres further east	Anytime
Follis Avenue	North	A point 18 metres east of Palmerston Avenue and a point 5.5 metres further east	Anytime
Kerr Road	North	A point 9 metres east of Hertle Avenue and a point 5.5 metres further east	Anytime
Stafford Street	East	A point 57.5 metres south of Adelaide Street West and a point 5.5 metres further south	Anytime

C. By inserting in Schedule III (Designated On-Street Loading Zones for Permit Holders), the following in alphabetical order by street name:

Armoury Street	South	A point 26 metres east of University Avenue and a point 10 metres further east	Anytime
Ashdale Avenue	East	Fairford Avenue and a point 13.5 metres north	8:30 a.m. to 5:00 p.m. daily
Mutual Street	East	A point 87.4 metres north of Queen Street East and a point 11 metres further north	Anytime
