### CITY OF TORONTO

### **BY-LAW No. 57-2008**

To amend City of Toronto Municipal Code Chapter 19, Business Improvement Areas, to include the new Dundas-Bathurst Business Improvement Area and to establish a Board of Management for the Dundas-Bathurst Business Improvement Area.

WHEREAS City of Toronto Council, by the adoption of By-law No. 1030-2007, designated an area along Dundas Street West, between Bathurst Street and Grace Street, as a business improvement area under Municipal Code Chapter 19, Business Improvement Areas; and

WHEREAS Toronto and East York Community Council has established a board of management for the Dundas-Bathurst Business Improvement Area, and appointed members to the Dundas-Bathurst Business Improvement Area Board of Management for a term expiring on November 30, 2010, or as soon thereafter as successors are appointed; and

WHEREAS Schedule A of the City of Toronto Municipal Code Chapter 19, Business Improvement Areas, must be amended to include the new Dundas-Bathurst Business Improvement Area Board of Management;

The Toronto and East York Community Council HEREBY ENACTS as follows:

- **1.** The City of Toronto Municipal Code Chapter 19, Business Improvement Areas, is amended as follows:
  - A. The table in Schedule A, Boards of Management is amended by adding the new Dundas-Bathurst Board of Management as set out in Schedule A attached; and
  - B. Schedule A, Maps is amended by adding the attached maps of the Dundas-Bathurst Business Improvement Area.
- **2.** A Board of Management for the Dundas-Bathurst Business Improvement Area is hereby established.




