CITY OF TORONTO

BY-LAW No. 126-2008

To amend City of Toronto Municipal Code Chapter 545, Licensing, to amend the business licensing threshold provisions and establish a taxicab operators log.

WHEREAS the *City of Toronto Act, 2006* grants the City of Toronto the authority to enact by-laws for the licensing, regulating and governing of businesses wholly or partly carried on in the City of Toronto; and

WHEREAS Council enacted By-law No. 117-2004 at its meeting on January 27, 28 and 29, 2004, establishing administrative thresholds for the issuance of business licences; and

WHEREAS Council has decided that it is appropriate to refine the administrative thresholds established by introducing a demerit-point system; and

WHEREAS Council has decided that a demerit-point system will provide improved guidance to Municipal Licensing and Standards in their evaluation of the significance of infractions of the City of Toronto Municipal Code or other legislation committed by business licence holders or applicants; and

WHEREAS the demerit-point system will be considered by Municipal Licensing and Standards when individuals apply for the issuance or renewal of a business licence or consideration is being given to the possible suspension or revocation of a business licence issued by the City; and

WHEREAS Council has decided that requiring taxicab drivers and owners to complete and maintain an operators log instead of a trip sheet, is appropriate and sufficient to assist Municipal Licensing and Standards to investigate public complaints and enforce applicable provisions of the Municipal Code;

The Council of the City of Toronto HEREBY ENACTS as follows:

1. Appendix K to Chapter 545, Licensing, Business Licensing Thresholds, is amended by deleting the words of subsection 1(A)(ix) and inserting in their place:

“(ix) seven or more by-law demerit points within the last 12 months;”
2. Appendix K to Chapter 545, Licensing, Business Licensing Thresholds, is amended by repealing subsection 1(A)(x).
3. Appendix K to Chapter 545, Licensing, Business Licensing Thresholds, is amended by deleting the words of subsection 1(A)(xii) and inserting in their place:

“(xii) five or six by-law demerit points within the 12 months immediately preceding the date of application for a licence or renewal, plus a suspension of a licence held by the individual or corporation as a result of any violation of the business licensing

thresholds in the 12 month period immediately preceding the previous date of licence issuance or renewal;”

4. Appendix K to Chapter 545, Licensing, Business Licensing Thresholds, is amended by deleting the words of subsection 1(C)(xi) and inserting in their place:

“(xi) seven or more by-law demerit points that are more than 12 months old, but not more than three years old;”
5. Appendix K to Chapter 545, Licensing, Business Licensing Thresholds, is amended by deleting the words of subsection 1(E)(i) and inserting in their place:

“(i) five or six by-law demerit points concerning the licensed business or individual, or any other of the individual or corporation’s businesses that are licensed or are required to be licensed, or any of the individual or corporation’s prior businesses that were licensed or required to be licensed, within the 12 months immediately preceding the date of application for a licence or renewal; and”
6. Appendix K to Chapter 545, Licensing, Business Licensing Thresholds, is amended by deleting the words of subsection 1(G)(i) and inserting in their place:

“(i) five or six by-law demerit points concerning the licensed business or individual, or any other of the individual or corporation’s businesses that are licensed or are required to be licensed, or any of the individual or corporation’s prior businesses that were licensed or required to be licensed, within the 12 months immediately preceding the date of application for a licence or renewal; and”
7. Appendix K to Chapter 545, Licensing, Business Licensing Thresholds, is amended by deleting the words of subsection 2(A)(viii) and inserting in their place:

“(viii) seven or more by-law demerit points within the last 12 months;”
8. Appendix K to Chapter 545, Licensing, Business Licensing Thresholds, is amended by repealing subsection 2(A)(ix).
9. Appendix K to Chapter 545, Licensing, Business Licensing Thresholds, is amended by deleting the words of subsection 2(A)(xi) and inserting in their place:

“(xi) five or six by-law demerit points within the 12 months immediately preceding the date of application for a licence or renewal, plus a suspension of a licence held by the individual or corporation as a result of any violation of the business licensing thresholds in the 12 month period immediately preceding the previous date of licence issuance or renewal;”

- 10.** Appendix K to Chapter 545, Licensing, Business Licensing Thresholds, is amended by deleting the words of subsection 2(C)(vi) and inserting in their place:
- “(vi) seven or more by-law demerit points that are more than a year old, but not more than three years old;”
- 11.** Appendix K to Chapter 545, Licensing, Business Licensing Thresholds, is amended by deleting the words of subsection 2(E)(i) and inserting in their place:
- (i) five or six by-law demerit points concerning the licensed business or individual, or any other of the individual or corporation’s businesses that are licensed or are required to be licensed, or any of the individual or corporation’s prior businesses that were licensed or required to be licensed, within the 12 months immediately preceding the date of application for a licence or renewal; and”
- 12.** Appendix K to Chapter 545, Licensing, Business Licensing Thresholds, is amended by deleting the words of subsection 2(G)(i) and inserting in their place:
- (i) five or six by-law demerit points concerning the licensed business or individual, or any other of the individual or corporation’s businesses that are licensed or are required to be licensed, or any of the individual or corporation’s prior businesses that were licensed or required to be licensed, within the 12 months immediately preceding the date of application for a licence or renewal; and”
- 13.** Appendix K to Chapter 545, Licensing, Business Licensing Thresholds, is amended by deleting all Restriction Code 08 offences listed in Appendix K.
- 14.** Appendix K to Chapter 545, Licensing, Business Licensing Thresholds, is amended by adding the words “Schedule A” at the beginning of the title “Offences and Corresponding Restriction Codes.”
- 15.** Appendix K to Chapter 545, Licensing, Business Licensing Thresholds, is amended by adding “Schedule B, Demerit Point System” to Appendix K following the table of Offences and Corresponding Restriction Codes, a copy of which is attached as Appendix 1 to this By-law.
- 16.** The existing subsection 545-141, Trip Sheet, to Chapter 545, Licensing, is deleted and replaced with the following:
- Taxicab Operator Log
- A. Information to be recorded by driver
- (1) A driver or owner who drives a cab shall keep a record in the form attached hereto as Appendix D at the end of this chapter (referred to as an “Operator Log”) of the operation of the cab, and the Operator Log shall contain the following information for each shift or working period that the taxicab is operated:

- a. The number of the taxicab;
 - b. The provincial plate number of the vehicle;
 - c. The date and time on which the driver or owner started and finished work;
 - d. The taxicab driver or owner's licence number;
 - e. The signature of the taxicab driver or owner; and
 - f. The details of any incidents, as per subsection 545-148K(3).
- (2) A driver or owner who is driving a cab shall record the starting information required in the Operator Log prior to the commencement of any shift or continuous working period and shall record the ending information required on the Operator Log at the conclusion of any shift or continuous working period they work.
- (3) An owner shall ensure that the driver operating his or her cab completes the Operator Log as required by (A) above and provides the Operator Log to the owner, or his or her designated custodian, within 7 days of the conclusion of a shift.
- B. Operating Logs shall be kept by a designated custodian, who may be the owner, a designated agent or lessee who is responsible for the taxicab or otherwise rents out the taxicab to a taxicab driver, for a period of at least 12 months and shall be open to inspection by the Municipal Licensing and Standards Division which may remove such records and retain the same for a reasonable period of time.
- 17.** Subsection 545-148K(3) is amended by deleting the words "daily trip record" and replacing them with the words "taxicab operator log".
- 18.** The existing Appendix D, Trip Sheet for Taxicabs, to Chapter 545, Licensing, is deleted and replaced by Appendix 2 attached to this By-law, which is to be entitled Appendix D, Proposed Sample Taxicab Operator Log.
