BY-LAW No. 184-2008

To name the public lane between Danforth Avenue and Chatham Avenue, extending easterly from Jones Avenue to the easterly limit of the lane located east of Euston Avenue as “Ben Kerr Lane”.

WHEREAS City of Toronto Council has delegated the legislative authority for local routine matters, such as the naming of streets, to Community Councils by adopting Executive Committee Item 2.5, as amended, at its meeting held on February 5, 6, 7 and 8, 2007; and

WHEREAS pursuant to § 27-152E(5) of Chapter 27, Council Procedures, of the City of Toronto Municipal Code, Toronto and East York Community Council has the authority to pass a by-law naming the street; and

WHEREAS notice of the proposed by-law to name this public lane was posted on the notices page of the City’s website in accordance with the requirements of City of Toronto Municipal Code Chapter 162, and interested persons were given an opportunity to be heard at a public meeting held on February 12, 2008, and it is appropriate to name the public lane between Danforth Avenue and Chatham Avenue, extending easterly from Jones Avenue to the easterly limit of the lane located east of Euston Avenue as “Ben Kerr Lane”;

The Toronto and East York Community Council HEREBY ENACTS as follows:
